The Selected Candidates shall be guided by the following norms and conditions, as resolved by the District Recruitment Committee, Uttar Dinajpur Judgeship:-

- 1. The Selected candidates, as mentioned above shall be appointed purely on temporary basis and shall remain on probation for the period as provided in "The West Bengal District Court (Constitution of Service, Recruitment, Appointment, Probation and Discipline of Employees) Rules, 2015" & during his/ her period of probation, if it is found that the candidate/s is/are not fit for the post, then his/ her period of probation shall not be extended and he/ she will be removed from the service, automatically.
- 2. The candidates selected above, if already in Government Service whether in any Judgeship or in any Department of West Bengal or Union of India or any PSU, shall submit "No Objection Certificate" along with a certificate issued by his/ her Appointing Authority showing that there is no disciplinary proceeding pending against him/ her for the charge of corruption, insubordination or for any other reason and there is no criminal case arising out of his/ her rendering present service, pending or any other proceeding/s pending against him/ her.
- 3. The Candidates selected above shall have to appear before the Medical Board in the Office of the Medical Superintendent-cum-Vice Principal of the District on 17-02-2025 for their medical examination with his/ her individual reports of Blood RE, Urine RE, ECG, Blood Sugar PP and fasting. The Pathological Reports must be done after the date of publication of the instant panel at any Government registered Pathological Laboratory or Government Hospitals. The Candidates have also to collect TR Form No. 7 (5 copies) from the Office of the Medical Superintendent-cum-Vice Principal of the District and have to make necessary payment at SBI, Karnojora Branch after obtaining necessary endorsement from the Office of the MSVP of the District, on 17-02-2025. The candidate must obtain necessary endorsement of the the Medical Superintendent-cum-Vice Principal of the District on the back side of their Admit card.

The above selected candidates shall download and take print out (03 copies) of the blank Police Verification Roll which will be sent to him/ her through email message at their registered email ID and are to submit duly filled up Police Verification Roll (03 copies) along with attested copy of his/ her Educational Qualification on 20-02-2025 to the Office of the District Judge, Uttar Dinajpur at Raiganj. Original documents of educational qualifications and other testimonials viz Original Caste Certificate, Original EWS Certificate, Original Physical disability Certificate, Original Exempted Category Certificate, Original ID proof (Voter card/ AADHAR Card/ PAN Card/ Driving License) must be produced at the time of submission of filled in Police Verification form and the candidates must obtain necessary endorsement of the office of the undersigned acknowledging submission of the filled in Police Verification form on the back side of their Admit card and the Admit card along with the above two endorsements should be retained by the candidates and be produced at the time of the receipt of the appointment letter.

Suppression of any educational qualification or any other information by the candidate during submission of the Police Verification Roll may lead to removal of his/ her name from the above panel. Besides the VR Form, the above selected candidates shall have to furnish certificates, issued after publication of instant panal, testifying his character by two respectable persons unconnected with his school, college or university and not related to him/ her.

- 4. In case of non-submission of the Police Verification Roll on 20-02-2025 and non-appearance before the Medical Board on 17-02-2025, it will be treated that the candidate is not willing to join his/ her post and his/ her name will be deleted from the list of selected candidates.
- 5. The Appointing Authority shall reserve the right to de-list any candidate from the list of selected candidate, if it is found that for any other reason the candidate is not eligible for the post.
- 6. The selected candidates above will be issued Appointment Letter on receipt of satisfactory report on Police Verification Roll and Medical Fitness from the authorities concerned.
- 7. The issue of appointment letter to the candidates in the vacancy reserved for OBC A, OBC A (EC), OBC B & OBC B (Ex Serviceman) shall be abided by and shall be subject to the Judgement passed by the Hon'ble High Court, Calcutta on 22/05/2024 in WPO 60 of 2011 with WPA 22145 of 2010, WPA 8840 of 2020 with WPO 1160 of 2013 with WPO 578 of 2012 regarding OBC certificates.

The New entrants under Group D except sl. no: 21 and Group C as above are entitled to get "one Advance increment" from the date of their joining the service under Uttar Dinajpur Judgeship as per <u>G.O.No</u>. 895-JD/L/25-23/09 dated 20th July, 2012 of the Judicial Department, Govt. of West Bengal, issued with Concurrence of Finance (Audit) Deptt. Vide their U.O. No. 1253-Gr.P (Service) dated 31.03.2011 read with U.O. No.99 Group-P (Pay) dt. 29.06.2012 in compliance with the order of the Hon'ble Apex Court dated 07.10.2008.
